## COUNCIL MEETING

### MINUTES

A regular meeting of the Tennille City Council was held on February 18, 2019 with Mayor Eartha Cummings presiding. Council members present were Marlene Veal, Elaine Walk, Brainard Crawford, Booker T. Coleman, and Keith Lindsey.

The meeting was called to order at 6:00 p.m. by Mayor Cummings. Mayor Cummings led the pledge of allegiance to the flag and Mayor Pro-Tem Crawford led the invocation.

Mayor Cummings states that she will make a change to the agenda and go into executive session due to a councilmember that have to leave the meeting early.

#### Mayor and Council Comments

Mayor Cummings asked Councilwoman Walk for an update on the FEMA meeting. Ms. Walk states that the meeting went well and she will provide them with information on the chipping of the debris, the purchasing policy and the procurement of bids for the next meeting. Mayor Cummings reminded everyone of the city retreat that will be held April 12 & 13 at Ocmulgee State Park. She states that we will need a rooming assignment filled out. Mayor Pro-Tem Crawford stated that he will speak at the Rotary Club luncheon on the behalf of Mayor Cummings tomorrow. Councilman Lindsey stated that he will have the landscaping project design from Ms. Howard tomorrow and he will meet with the mayor to discuss it. Councilwoman Veal asked for an update on the potholes on Holmes Cannery Road. Mayor Cummings told her that she had not got with the Public Works department about it yet but she will take care of it. Mayor Cumming gave out a copy of HB-

302 that will be go to the House of Representatives for a vote next month. She states this bill will take the control from the city in regard to some building projects. She states that she is doing more research on it and we will do a resolution if needed at a later date. Mayor Cummings states that a citizen asks that the city put up Autistic child signs on her street due to her son having autism. Everyone agreed that would be fine.
