MINUTES

A regular meeting of the Tennille City Council was held on September 3, 2019 with Mayor Eartha Cummings presiding. Council members present were Elaine Walk, Brainard Crawford, Marlene Veal, and Keith Lindsey.

The meeting was called to order at 6:00 p.m. by Mayor Cummings. Mayor Cummings led the pledge of allegiance to the flag and Councilman Crawford led the invocation.

Approval of Minutes

Motion made by Elaine Walk, seconded by Marlene Veal, to accept the minutes from the August 19, 2019 regular meeting.

Departmental Reports

- Chief Cochran states that for the month of August the Police Department responded to 124 calls and court was not held in August. He states that the paperwork has been submitted to DOT for processing for the road closure for the BBQ Blast event.
- Mike Wiggins, did not attend or make a report for the month of August.
- Administration-Stacie Jordan, City Clerk, gave the accounts payable report for August with total of \$57,402.41. The cash balance for the Water acct is \$168,145.83 and the General acct is \$90,577.13.

New Business

Mayor Cummings states that we have a demo of the new website. City Clerk Stacie Jordan explained the layout of the website and some tabs that have been included. She explained that it is still a work in progress and that more pictures, tabs, etc. will be added before the website goes live.

Mayor Cummings states Public Works has completed the 3 major leaks that was waiting to be repaired. She states that a copy of the maps is provided that were completed by GIS Mapping and we are waiting on the big maps to come in the mail. If there are any changes we will let him know and run the ad in the paper at that time. Mayor Cummings states that she met with Tim Ingram and we are finishing the final things to close out the consent order. He will present some information about the well vs. the filtration system at the September 16 council meeting. Mayor Cummings states that we received a check for the LMIG application that was submitted online. We will be having a town hall meeting for the Branding project and to meet the superintendent on September 24, 2019. Councilwoman Walk asks if we have an update on the Queensborough situation. Mr. Howard states that he expects to receive a response soon. Councilman Veal states that her church will be sponsoring the toy drive again this year and if anyone is interested in helping a meeting will be held on Thursday, September at 6:00 at Citizens Bank. Mayor ProTem Crawford states that he has been working with Councilman Hartley and Georgia Power with replacing the lights throughout the city. He states that he would like for Public Works to start cleaning out the ditches in his area. There being no further business, **motion made by Keith Lindsey, seconded by Marlene Veal, to adjourn.
